In the face of interconnected global challenges and conflicts, the world grapples with significant hurdles that impede progress towards the aspirations outlined in the 2030 Agenda for Sustainable Development. Even though the COVID-19 pandemic has been declared over by the WHO, the long-term impacts persist. The pandemic has strained global health systems, disrupted essential services, and exacerbated vulnerabilities. It has also magnified existing issues, including poverty and hunger. Indeed, conflicts and crises persist in various regions, affecting a significant number of people in conflict-affected nations. These conflicts, coupled with the compounding effects of climate change acting as a threat multiplier, have further intensified displacement, instability, and vulnerability, exacerbating socio-economic disparities and impeding sustainable development efforts.

Considering this situation, it is crucial to recognize the significant investments made in addressing these complex challenges. Over the past decade, the international community has allocated an estimated \$349 billion towards peacekeeping, humanitarian relief, and refugee support, underscoring the scale and importance of these endeavors. However, despite these considerable efforts, much work remains to be done in the coming years to achieve the goals set by the UN SDGs. Indeed, the war in Ukraine has further exacerbated forced displacement, reaching record levels in 2021, with 6.5 million refugees, mostly women and children, fleeing the country. Globally, numbers of forced displacements are setting new records with more than 110 million people displaced by end of 2022 (UNHCR). In this situation, private actors such as NIRAS have a crucial part to play in contributing to a significant impact. With our expertise and unwavering commitment, we have a unique opportunity

Our services

We provide the following services which are specifically tailored to address key areas of focus on disaster risk management, migration, peacebuilding, and stabilization.

Conflict Resolution and Reconciliation

NIRAS focuses on tackling the causes of conflicts and promoting peaceful coexistence through dialogue, mediation, and initiatives for justice

Services

- Assisting individuals and institutions in overcoming conflict through non-violent means
- Facilitating dialogue and constructive engagement between the state and civil society, as well as among parties involved in conflicts
- Supporting initiatives and projects that address past experiences of violence, promoting reconciliation, and drawing lessons for the future
- Preventing and countering violent extremism (P/CVE) through addressing the underlying factors that contribute to its emergence such as discrimination, marginalization and governance issues

Displacement and Migration

NIRAS aims to address the challenges of displacement and migration by empowering individuals, supporting host communities, and providing advice to policymakers.

Services

- Addressing the urgent needs of refugees (and host communities) through infrastructure (like WASH and Education) projects in settlements
- Conflict mediation among refugees and between refugees and host communities in and around refugee settlements - Fund management in refugee programmes working with partners from both local civil society, INGOs, UN and local and central governments
- Assisting host communities in accommodating and providing services to large numbers of additional residents
- Supporting the reintegration of returnees economically, socially, and politically

Example: our regional project in the Horn of Africa [Supporting migrants, refugees, and host communities](#) aiming to create economic opportunities, improve living conditions, and promote social cohesion among refugees, migrants, and host communities in the IGAD region by promoting inclusive, participatory investment planning, and implementation in selected areas.

Disaster Risk Management

NIRAS takes a comprehensive approach to disaster risk management, focusing on prevention, response, and recovery measures.

Services

- Developing appropriate infrastructure and early warning systems to prevent disasters
- Providing immediate emergency assistance and implementing reconstruction measures
- Promoting risk reduction measures in national policies and integrating them into poverty reduction strategies and development plans

[NIRAS has been working in Ukraine for close to 25 years](#), notably by implementing the Technical Assistance to Support the Implementation of the Ukraine Recovery Programme (URP) funded by the European Investment Bank.

Strengthening State Capacities

NIRAS strengthens the legitimate state monopoly on the use of force through security sector reform and capacity building of security agencies.

Services

- Supporting democratic oversight and accountability in the security sector (SSR, DDR,...)
- Enhancing the capacity of security and law enforcement agencies to protect the population
- Promoting peace, stability, and development by creating a framework for the protection of individuals and addressing regional and global security risks

Funded by the EU, the [NIRAS-led Technical Assistance](#) supports a reinforcement of the Seychelles' Department of Legal Affairs to improve efficiency in drafting regulations relating to anti-money laundering, confiscation of crime proceeds, and anti-corruption.

Monitoring Evaluation and Learning (MEL) / results-based management (RBM) / Evaluations / surveys

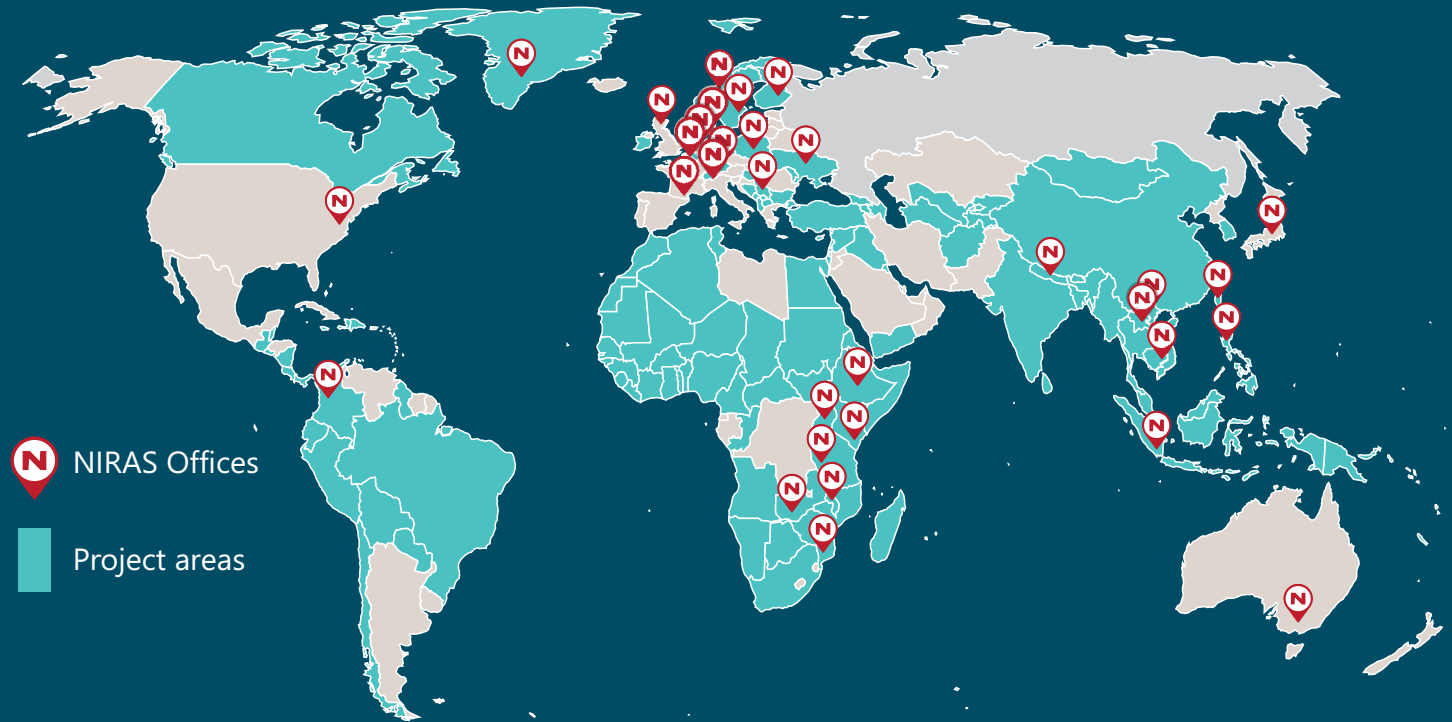
